ALL OTHER OFFICE FUNCTIONS ARE PERFORMED BY VOLUTEERS OR OUTSIDE SERVICES (BOOKKEEPING AND PAYROLL). IN PREVIOUS YEARS A CPA HAS PREPARED THE TAX RETURNS ON A PRO BONO BASIS. DUE TO THE GROWTH OF THE REVENUE OF THE AGENCY, THE ESTABLISHMENT OF A FURNITURE OUTLET FOR EXCESS DONATED FURNITURE (THRIFT SHOP) AND THE INCREASED NUMBER OF HOMES FURNISHED FOR THE YEAR FROM 97 IN THE PREVIOUS YEAR TO 143 IN 2018, THE EXECUTIVE DIRECTOR WAS OVER BURDENED.

IN 2018, THE ORGANIZATION WAS INFORMED THAT IT REQUIRED ADDITIONAL ACCOUNTING SUPPORT THAT THE CPA PREPARING THE RETURN IN THE PAST WAS UNABLE TO PROVIDE. THE EXECUTIVE DIRECTOR INTERVIEWED SEVERAL FIRMS THAT COULD PROVIDE THE REQUIRED SERVICES AND WAS IN THE PROCESS OF OBTAINING PROPOSALS AND EVALUATING THEM. HOWEVER, DURING THE PROCESS A FIRM WAS NOT SELECTED BY THE ORIGINAL DUE DATE OF THE RETURN, AND THE EXECUTIVE DIRECTOR FAILED TO INFORM THE PRIOR YEAR CPA, SO THAT AN EXTENSION REQUEST COULD BE PREPARED AND FILED.

IN NOVEMBER 2019, THE EXEUTIVE DIRECTOR CONTACTED MY OFFICE REGARDING THE PREPARATION OF THE TAX RETURN. AS THE CPA WHO PREPARED THE RETURNS IN THE PAST, I BEGAN TO GATHER THE INFORMATION REQUIRED TO PREPARE A COMPLETE RETURN AND PREPARED THE RETURN AS EXPEDIOUSLY AS POSSIBLE.

SUBSEQUENT TO OUR MEETING THE ORGANIZATION HAS BEGAN THE PROCESS ENGAGE A NEW ACCOUNTING FIRM, AND THEY WILL PREPARE THE TAX RETURN IN THE FUTURE.

BASED UPON THE FACT THAT THE ORANIZATION WAS ATTEMPTING TO TRANSITION TO AN ACCOUNTING FIRM AND THERE WAS MISCOMMUNICATION REGARDING THE PREPARATION OF THE 2018 TAX RETURN AND THE REQUIRED EXTENSION, THAT THE GROWTH OF THE ORGANIZATION WAS SIGNIFICANT WITHOUT ANY INCREASE IN THE MANAGEMENT OF THE OPERATION, THAT THE PENALTY WOULD BE A SIGNIFICANT BURDEN TO THE ORGANIZATION AS SUBSTANTIALLY ALL OF THE ASSETS ARE IN THE FORM OF INVENTORY, WHICH IS USED TO COMPLETE THEIR MISSION OF FURNISHING HOMES FOR THOSE IN NEED AND NOT CASH AND THERE WAS NO WILLFUL INTENT TO FILE A LATE TAX RETURN.
